Rustic Weddings and Rentals

I understand I am renting event items from Rustic Weddings and Rentals and understand the following:

1. Items being rented will not be released to me until the items, and the damage deposit are paid in full NO EXCEPTIONS.
2. There is a \$20.00 charge on all returned checks.
3. I am responsible for keeping the date and time set for picking up and returning rental items. If the items are not returned on the agreed date, I understand I am responsible for a late fee of \$10.00 per day.
4. There will be no refunds for any items I rented but did not use.
5. That if I do not pay the 20% holding fee, the items I want to rent may no longer be available to me.
6. I will not hold Rustic Weddings and Rentals liable for any injury or injuries obtained by any persons helping to set up, arrange or picking up any items being rented.
7. 50% damage deposit is due prior to event and can be refunded if the items are returned in the same condition as when they were rented.
 - a. They are packed and folded in their proper boxes or tubs, bubble wrap, zip lock bags, saran wrap or folded and wrapped around correct cardboard pieces with their measurements.
 - b. Vases, glassware, plates, votives, candy dishes, etc., all need to be washed before being returned and free from any remnants from event.
 - c. Renter is responsible for replacement costs.
8. That if any items are broken, cracked, torn, lost or not returned I will be responsible for the replacement fee, which is not covered by the damage deposit and will be charged an additional 20%.

By signing below, I acknowledge that I have read, understand and agree to abide by the terms of this contract. I understand that if I, or anyone related to my event fails to meet the terms of this contract, I personally, will be financially responsible, up to and beyond the amount of my security deposit, for all charges incurred related to my event.

Any changes or additions to this contract and its related documents must be made in writing, and signed by both parties above.
