The times and staging area will be the same as in previous years. The Fair Board will provide personnel to assist the City Police

with street closings and manning of the barricaded intersections before, during and after the parade. The Fair Board would also like to request the use of the parking area West of the Community Center, commonly known as the City Marina for the carnival to set up during the Fair April 25th–28th. Set up will occur on April 23rd and 24th with possible lot use for carnival truck parking and staging the afternoon of April 22nd. This is the same as previous years. The council agreed to both requests.

The committee is discussing an option of imposing some type of fee or tax so that just not the citizens of Asotin County are responsible for paying for the new jail. Councilmember Bly asked how many cells the current jail has. Police Chief, Monte Renzelman stated it should only hold 45 but there are about 50. Police Chief, Monte Renzelman stated there is a variety of professional and public persons who are on the Jail Committee and multiple persons who are helping with research and input. Councilmember Loseth asked if the Jail Committee would consider input from current public defenders to get a fuller picture from the courts side of the incarcerations. Councilmember Paris stated he is available to meet anytime.
